Direct Deposit benefits include:

- Elimination of mail delays resulting in quicker payments
- Reduction of payment issues due to lost, stolen or misdirected checks
- Less trips to the bank and no check holds
- Greater certainty around payment timing for cash planning purposes
- Access check detail anytime, anywhere with online access through EnergyLink (this is available with or without Direct Deposit)

Requirements:

- Direct Deposit payments are only available for accounts drawn within the United States
- For your protection, we cannot accept temporary checks or deposit slips. If you are unable to provide a voided check, please obtain a letter from your bank detailing your Direct Deposit payment instructions.
- If you are sending information for a Trust and you are depositing into the Trustees' personal account rather than the Trust account, please have your bank provide documentation that they have a copy of the Trust documents.
- Names on the bank account must match the names in which the interest is held.
- Dual signatures are required for joint accounts in order to enroll.

If you would like to take advantage of this voluntary service, please fill out the enclosed Direct Deposit Enrollment Form and return with all required documentation. Please note that you will continue to receive a paper check until we process your Direct Deposit request (this could take up to two revenue cycles or 60 days). Also, if you choose to receive electronic payments, you will only be able to view your check detail via [www.energylink.com](http://www.energylink.com) (formerly known as JIBLink). This is a system requirement and we cannot make exceptions.
